### AGREEMENT

I agree upon behalf of myself or the minor user I am representing to accept **AS IS** all equipment to be provided during a Bridger Bowl Ski Program, and I agree to accept full financial responsibility for the care of the equipment while it is in the user's possession. I will be responsible for the replacement at full value of any equipment provided under this form, but not returned to the Bridger Bowl Ski Shop. I agree all rental equipment will be returned clean and undamaged.

I agree that either I, or a second rental shop technician, will execute the verification of the visual indicator settings for each session. All user information I provide will be true and correct. I understand it is my and/or my minor child's responsibility to notify the Bridger Bowl Ski Shop if there are any changes in the user's height, weight, shoe size, skier type or stance. I agree that I or the minor user I am representing will not use any rental equipment to be provided until the use and function of the equipment is fully understood by me or the minor user I am representing.

### WARNING, NOTIFICATION OF RISKS PLEASE READ CAREFULLY BEFORE SIGNING

I understand and agree that skiing, snowboarding and related activities are **HAZARDOUS** and that injuries are common and ordinary occurrences during these activities. **I AGREE TO ASSUME ALL RISKS** of death or of injury to any part of the user's body while using this equipment.

**For Alpine Ski Equipment:** I understand the ski-boot-binding system is designed to release the boot from the ski when certain forces on the system reach preset values, but that the binding **WILL NOT RELEASE OR RETAIN** at all times where release or retention may prevent injury, and that it **CANNOT** prevent all injuries to any part of the user's body. I understand and agree that lower settings on my bindings will increase releasability but also increase the risk of injury due to inadvertent release, that higher settings on my bindings will increase retention but also increase the risk of injury due to non-release, and that injuries due to unwanted release or retention are inherent risks of the sport.

**For Snowboards, Skiboards:** I understand that these systems function differently from Alpine ski bindings in that snowboard and skiboard bindings **WILL NOT RELEASE** in falls or accidents. I understand and agree that these systems **DO NOT PROTECT** against any type of injury and that any injuries resulting from these circumstances are inherent risks of the sport.

I understand and agree that certain risks of skiing and snowboarding may be reduced, but not entirely eliminated, by taking lessons, by following "**YOUR RESPONSIBILITY CODE**" which is posted at most wintersports areas and by using reasonable care and common sense. I further understand that a leash or other runaway prevention system must be used with all skis and snowboards at all times, including while riding lifts and while carrying snowboards on or near a slope, in order to reduce the risk of injury to others.

To the fullest extent allowed by law, I hereby agree to forever **RELEASE AND HOLD HARMLESS** Bridger Bowl Inc., and all manufacturers and distributors of this equipment, as well as their owners, agents, employees and affiliated companies, from **ANY AND ALL RESPONSIBILITY OR LEGAL LIABILITY** for any injuries, damages or death to any user of any equipment listed on this form, whether resulting from **NEGLIGENCE** or any other cause. I further agree that **I WILL DEFEND AND INDEMNIFY** them if any claim or action is pursued for any injuries, damages or death relating to skiing, snowboarding or any related activities involving the use of this equipment.

I accept this equipment "**AS IS**" and with **NO WARRANTIES**, express or implied, beyond those stated in this agreement and in the manufacturer's written limited warranty, if any.

This document is a **LEGALLY BINDING CONTRACT** which supersedes any other agreements by or between the parties, and which constitutes the **FINAL AND ENTIRE AGREEMENT** regarding this transaction and this equipment. This agreement is intended to provide a **COMPREHENSIVE RELEASE OF ALL LEGAL LIABILITY**, which is binding upon and for the benefit of all parties, their heirs, agents and assigns, but it is not intended to assert any claims or defenses that are prohibited by law. If any part of this agreement is held to be invalid or unenforceable, the remainder shall be given full force and effect. The specific legal rights of the parties may vary among different states and provinces.

# CHOOSE YOUR SKIER TYPE



## Selecting Your Skier Type is Your Responsibility!

Your skier type, height, weight, age and ski boot sole length are used by the shop technician to determine the release/retention settings of your bindings. It is important to provide accurate information. Inaccurate information may increase your risk of injury.

**Consult the following descriptions to select your Skier Type.**

### **TYPE I** **Ski Cautiously**

- Prefer slower speeds.
- Prefer cautious skiing on smooth slopes of gentle to moderate pitch.
- Prefer lower than average release/retention settings.
- Prefer an increased risk of inadvertent binding release in order to gain increased releasability in a fall.
- Entry-level skiers uncertain of their classification.

### **TYPE II** **Ski Moderately**

- Prefer a variety of speeds.
- Prefer to ski on varied terrain.
- Skiers not classified as Type I or Type III.
- Prefer average release/retention settings appropriate for most recreational skiing.

### **TYPE III** **Ski Aggressively**

- Prefer faster speeds.
- Prefer fast and aggressive skiing on slopes of moderate to steep pitch.
- Prefer higher than average release/retention settings.
- Prefer decreased releaseability in a fall in order to gain decreased risk of inadvertent binding release.

If, from experience, you have been dissatisfied with the release/retention settings that result from your normal skier classification, or if you have some other special concern, you may wish to select lower or higher skier classifications ((**Type -I**) or (**Type III+**)) or select skier type designations that are different for twist and forward lean. Mention your dissatisfaction to your binding technician.

(**Type -I**) is for skiers who desire lower release/retention settings than Type I and will further increase the risk of inadvertent binding release in order to gain increased releasability in a fall.

(**Type III+**) is for skiers who desire higher release/retention settings than Type III and will further decrease releasability in a fall in order to gain decreased risk of inadvertent binding release.

### HELMET WARNING, NOTIFICATION OF RISKS PLEASE READ CAREFULLY

I understand and agree that skiing, snowboarding and related activities are dangerous and that injuries are common and ordinary occurrences during these activities. I agree to assume all risks of death or injury to any part of the user's body which may result from skiing, snowboarding and the use of the helmet.

I understand and agree that no helmet can protect the user against all foreseeable impacts to the head, and that skiing and snowboarding can expose the user to forces which exceed the limits of protection offered by this helmet. I understand that this helmet does not guard against injury to the neck, spine or any other part of the user's body, and that these limitations are inherent risks of any activity in which this helmet will be used.

This helmet must fit properly in order to maximize its performance, and I agree that this helmet has been properly fitted to me or my minor child by the provider. Instruction on the use of the helmet has been made clear to me and I understand the function of the helmet. I warrant that the helmet is comfortably snug when the chin strap is fastened and there is no significant movement of the helmet when the user's head is shaken. I further warrant that the person for whom the helmet was sized will be the only person using the helmet during this rental period.

**For Ski Physical Education and Group Participants:**

*I understand as parent or guardian of the minor child named above, I should be present to confirm proper fit of the helmet. If I can not be present, a chaperone or coordinator from the school or group is to verify proper helmet fit on my behalf.*

If the helmet is damaged or involved in any kind of accident, the user will immediately return it to the Bridger Bowl Ski Shop and report the accident or damage.

I understand I will be responsible for the replacement of the helmet at full retail value if it is not returned to the shop. I acknowledge it is my responsibility to return this helmet to the Bridger Bowl Ski Shop in clean condition and agree to pay for the helmet in the event the helmet is abused or damaged beyond normal wear and tear.

ON BEHALF OF MYSELF AND/OR MY MINOR CHILD NAMED ON THIS FORM, I HEREBY RELEASE, HOLD HARMLESS, AND INDEMNIFY BRIDGER BOWL INC., ITS EMPLOYEES, AGENTS, OFFICERS AND DIRECTORS FROM ANY AND ALL LIABILITY FOR ANY LOSS, DAMAGE, EXPENSE OR INJURY (INCLUDING DEATH) TO MYSELF OR MY MINOR CHILD RESULTING FROM THE RISKS DESCRIBED HEREIN, REGARDLESS OF WHETHER SUCH RISKS RESULT FROM THE NEGLIGENCE OF BRIDGER BOWL INC., AND THE PARTIES RELEASED.
